Overcoming cultural unfamiliarity: We recognise the challenges faced by women from minority communities in navigating a foreign country and culture and want to create a pathway to support them to access the health and social services they need.

Seeking understanding before action: We acknowledge the highly complex challenges we are focusing on and will approach an area of need with deep curiosity and a commitment to seeking consultation, input, and discovery to ensure the relevancy and appropriateness of our actions.
